### **RULES:**

Type of Strings Ensemble: Limited to three (3) Types -

- A. Piano Trio (piano, violin, cello/contrabass),
- B. String Quartet (2 violins, viola, cello/contrabass), and
- C. String or Piano Quintet (string quintets or a string quartet plus a piano).

**Two Divisions - Senior and Junior:** Open to Chicago and nearby area's youths of ages 19 or younger. *Senior Division:* Group's Average Age older than 13 and younger than 19 on April 7, 2019, and **Junior Division:** Group's Average Age at 13 or younger than 13 on April 7, 2019.

**Music: Classical Music:** Two "Self-nominated" pieces of participants' choices. **Each piece is limited to a <u>15</u> minutes.** *Performers are to perform from original music, and bring three original scores to the judges.* 

Application Fee: \$30 per person.

## **AWARDS:**

Every participant will receive a *Certificate for Participation* which will be presented at the time of competition. Each group will be provided with *judges comments* on their respective performance by mail after the competition.

In the afternoon, a join-in session where 2 to 4 groups may be invited to perform in front of the judges and receive on the spot comments from the judges.

Every Senior and Junior Division 1st, 2nd, or 3rd place winners will receive:

- A. Monetary cash price;
- B. An OPUS scholarship certificate; and
- C. Invitation to perform in a Winners Concert (see posting on the OPUS website).

#### Cash Price:

1st Place Ensemble: \$600/Senior Ensemble and \$400/Junior Ensemble;

plus \$200 Outstanding Scholarship to the 2019 OPUS Chamber Music Camp/person;

2<sup>nd</sup> Place Ensemble: \$400/Senior Ensemble and \$200/Junior Ensemble;

plus \$100 Merit Scholarship to the 2019 OPUS Chamber Music Camp/person;

3<sup>rd</sup> Place Ensemble: \$200/Senior Ensemble and \$100/Junior Ensemble;

plus \$50 Honor Scholarship to the 2019 OPUS Chamber Music Camp/person.

Some groups may receive Honorable Mentions. Judges and Music Director may <u>not</u> necessarily to grant all 1st, 2nd, and 3rd place, and Honorable Mention. *All judges and Music Director decisions will be final.* The OPUS Scholarship to the 2019 OPUS Chamber Music Camp will be used toward tuition reduction when actually register and attend.
